Dear Mr. Goetsch:

Thank you for your recent inquiry on March 31, 2010 about filing a whistleblower complaint against your client's employer or former employer. Your complaint could be investigated by the United States Department of Labor, Occupational Safety and Health Administration (OSHA), under several different laws, including: *The National Transit Systems Security Act (NTSSA)*; *the Federal Rail Systems Act (FRSA)*; *Section 11(c) of the Occupational Safety and Health Act (the OSH Act)*;

If you elect to pursue your claim under either NTSSA or FRSA, you cannot file your retaliation complaint under any other law, because NTSSA and FRSA require an "election of remedies." Specifically, NTSSA and FRSA provide, "An employee may not seek protection under both this section and another provision of law for the same allegedly unlawful act" of the employer.

For this reason, it is necessary that you advise me under which law you wish your complaint to be investigated by OSHA. Please return the attached election of remedies form to me, or contact me by telephone to make your election, **within 10 calendar days of your receipt of this letter**. An investigation will not commence until we receive this information from you.
